## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- First-aid measures general : If medical advice is needed, have product container or label at hand.
- First-aid measures after inhalation : If inhaled, remove from source of exposure to dusts to fresh air and keep at rest in a position comfortable for breathing. Give oxygen or artificial respiration if necessary. Obtain medical attention if breathing difficulty persists. Persons who have inhaled decomposition gases (e.g. in a fire) should obtain immediate medical attention.
- First-aid measures after skin contact : Wash skin thoroughly with mild soap and water. Obtain medical attention if irritation develops or persists.
- First-aid measures after eye contact : Immediately rinse with water for a prolonged period (at least 15 minutes) while holding the eyelids wide open. Obtain medical attention if irritation develops or persists.
- First-aid measures after ingestion : Do not induce vomiting. Seek medical attention if a large amount is swallowed. Get medical advice and attention if you feel unwell (or if a large amount of MAP is ingested [small children, more than 50 g]) Drink large amounts of water (or milk if available) to dilute stomach contents. Ingestion of small quantities is unlikely to cause toxic effect.

### 4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries : Irritation to eyes, skin and respiratory tract.
- Symptoms/injuries after inhalation : Inhalation of a large amount of dust may cause respiratory irritation with difficulty in breathing, sore throat, and cough. Symptoms may be delayed.
- Symptoms/injuries after skin contact : May cause skin irritation.
- Symptoms/injuries after eye contact : May cause eye irritation.
- Symptoms/injuries after ingestion : If a large quantity has been ingested : Abdominal pain. Diarrhea. Nausea. Vomiting.

Reactivity : Stable at ambient temperature and under normal conditions of use.

## 5.3. Advice for firefighters

Firefighting instructions : Keep personnel removed from and upwind of fire, when strongly heated, MAP will decompose giving off ammonia.

Protection during firefighting : Wear full fire-fighting turn-out gear (full Bunker gear) and respiratory protection (SCBA).

Other information : Do not allow run-off from fire fighting to enter drains or water courses.

## SECTION 6: Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

General measures : Do not breathe fumes from fires or vapours from decomposition.

#### 6.1.1. For non-emergency personnel

Protective equipment : Wear suitable protective clothing, gloves and eye/face protection. Wear tight fitting goggles in dusty areas to reduce dust exposure to the eyes.  
If skin irritation occurs, wear long sleeves.

Emergency procedures : Collect as any solid. Ventilate area.

#### 6.1.2. For emergency responders

Protective equipment : Wear suitable protective clothing, gloves and eye/face protection.

Emergency procedures : If possible, stop flow of product. Contain and collect as any solid. Ventilate area.

Provide adequate ventilation. Avoid generation of dust during clean-up of spills. If uncontaminated, recover and reuse product.

### 8.2. Exposure controls

- Appropriate engineering controls : Ensure adequate ventilation, especially in confined areas and avoid high dust concentration.

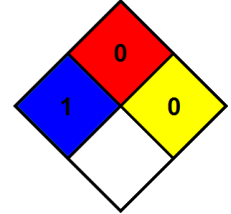
